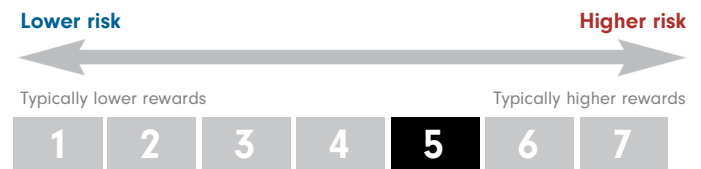

Objectives and Investment Policy

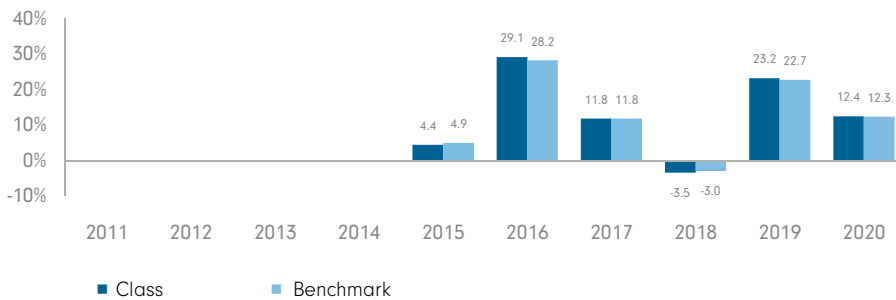

Objectives and Investment Policy

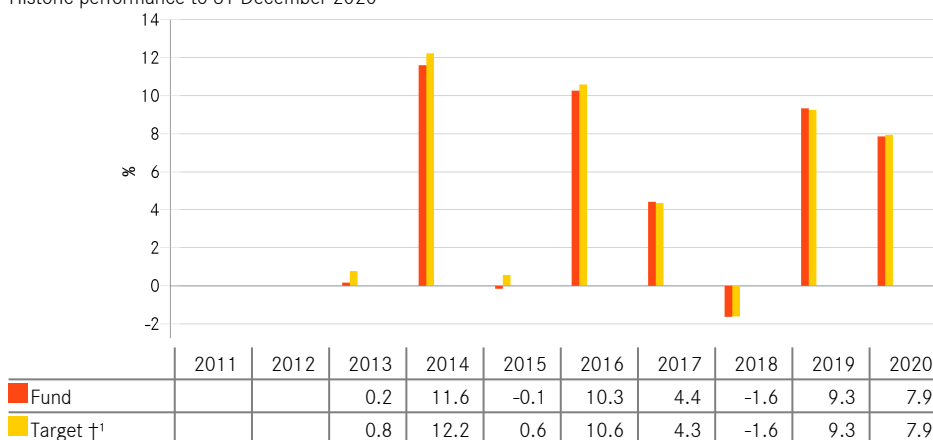

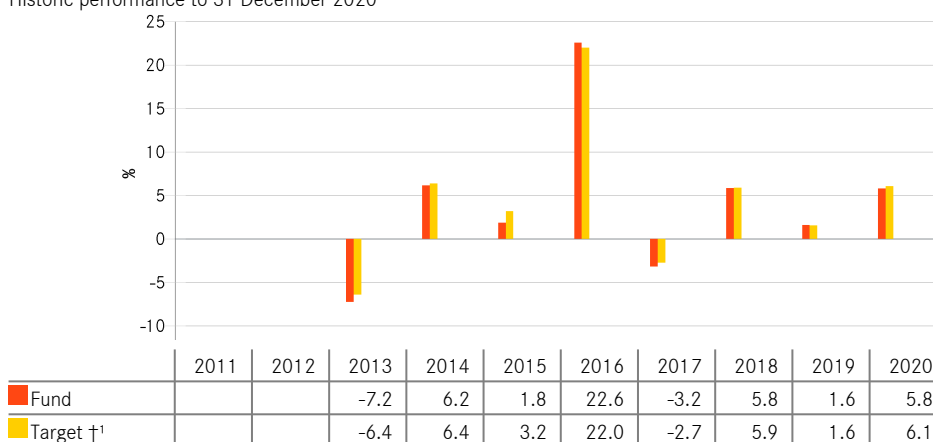

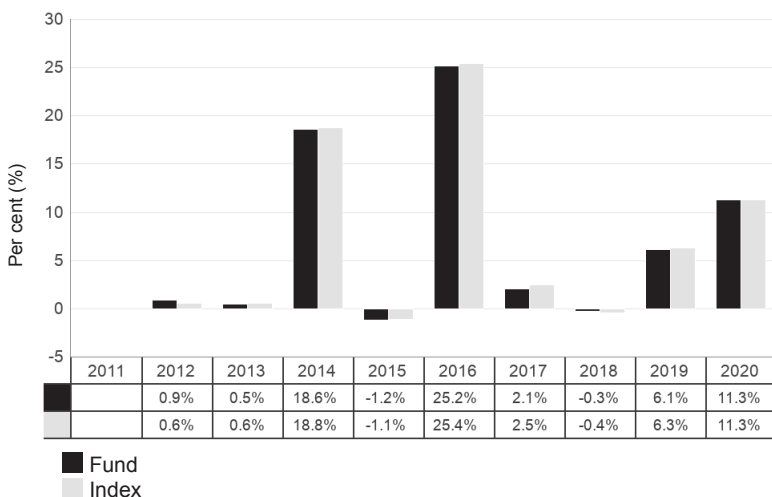
